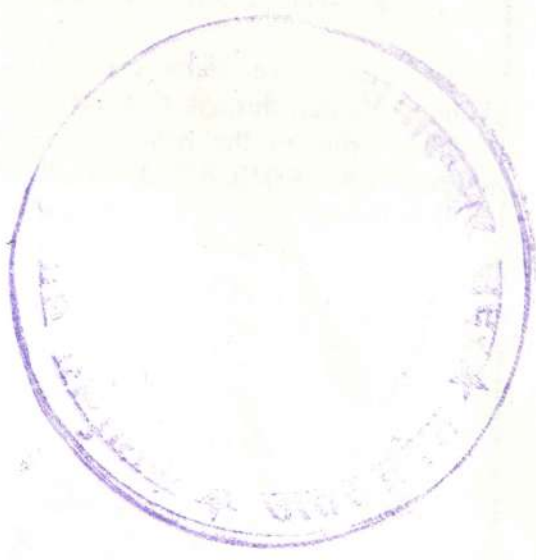

4 **AIMS & OBJECTS :** The Trust has been established to fulfill the following and objects :

- (i) To establish, maintain, run, manage, grant aid to schools, institution, research centers, colleges, study centres, vocational training centres, library, reading rooms and book banks, laboratories for development of education from pre-school level to University level and diffusion of knowledge and learning amongst public in general.
- (ii) To give scholarships, stipends, and / or financial help for the education and literacy of the general public and also to help or arrange for the education of religious and linguistic minorities, orphans, the destitute, women, children, adults and needy sections of the society.
- (iii) To publish books and print magazines, periodicals, newspapers for benefits of the general public, scholars and students.

- (v) To promote, establish, maintain homes for persons belonging to religious and linguistic minorities, aged, orphans, destitute people, widows, poor, disabled, physically handicapped.
- (vi) To give, provide or otherwise arrange for the medical help, aid, and / or assistance including medical and / or surgical treatment, hospitalization, distribution of free medicines, foods, clothes, and other necessities and with this view to establish, run, manage dispensaries, hospitals and nursing homes etc.
- (vii) To conduct, hold, propagate, assist and help in encouraging sports and games activities and events.
- (viii) To conduct any other activities which are in consonance with the laws of the land as they exist now and may prevail any time in the future.

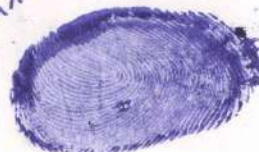

IN PURSUANCE OF THE ABOVE OBJECT THE TRUST MAY:

- a) Acquire by purchase, lease, mortgage, will, gift, grant, legacy, bequest, exchange, right, privilege or otherwise from any person or persons, company, society, government, institution, organization or anybody whatsoever, moveable or immovable property or properties deemed necessary or useful for any purpose of the Trust.
- b) Erect buildings or structures, to further any purpose or purposes of the Trust and to maintain, develop, improve, alter, repair, demolish or reconstruct the same or any portion thereof.
- c) Take or receive any gifts - whether money or property, moveable or immovable - donation in the form of debentures, stocks, shares or securities in any company or society whether in corporate or not or whether by gift by a person living or by legacy bequests, will or foundation and whether subjects to any special trust or for works connected therewith and take steps for the securing of such contributions for funds as may be deemed expedient from time to time.
- d) Alienate by way of sale, mortgage, lease, release, loan, charge, hypothecation, pledge, exchange, hiring out, gift or otherwise with or without security of properties or funds of the Trust or any portion thereof including the making or giving of subscriptions, contributions, assistance, pecuniary or otherwise to such institutions, bodies or persons as may be deemed necessary or expedient from time to time.
- e) Lend money free of interest, invest, lay aside, deposit in bank or otherwise deal with moneys of fund of the trust not immediately required for the objects of the Trust and to subscribe or purchase, acquire, hold, sell, endorse and negotiate in debentures, stocks, shares and securities of every description in the money market, in conformity with the provision contained in Section 20 of the Indian Trust Act. 1882.
- f) Borrow or raise funds with or without security in any manner the trust may think fit and repay the same.

6. **BOARD OF TRUSTEES (COMPOSITION & POWERS) :**

(a) That Board of Trustees shall have at a time not more than ten (10) members. At present the Board has only seven (7) members of whom one (1) namely Mr. Saad Ali Khan who is the Settler/ Executor of this Trust, whose name is mentioned on page one of the Trust Deed, shall be Life Trustee. The remaining six (6) Trustees whose names are mentioned above in the Deed of Trust shall have the status of Associate Trustees and their term of office shall be three (3) years from this date. On the expiry of the period of three years, the Life Trustee may re-appoint/re-nominate any or all of these Associate Trustees for such term and on such conditions as the Life Trustee may deem fit. The Life Trustee may also co-opt three more Associate Trustees for a similar term and on similar terms and conditions. Such an arrangement and procedure shall also continue in future. The Life Trustee shall also be the Managing Trustee of the Trust and its ex-officio Chairman/Chairperson

(ii) That the general meeting of Board shall be requisitioned once in a year (within six months of the ending of the accounting year) to pass account and budget of the Trust. The Managing Trustee may call an Emergent or Ordinary Meeting of the Trust with a notice of at least 24 hours. The quorum of the meeting shall be three (3).

- (iii) That the Managing Trustee can at any time and at his sole discretion remove or expel any or all Associate Trustees and appoint new Associate Trustees without assigning any reasons for so doing. No trustee shall have right to remain a trustee.
- (iv) Associate Trustees may retire, resign or relinquish his/her office at any time, with one month's prior notice to the Managing Trustee.
- (v) That the Managing Trustee shall appoint employees and frame regulations for their service contracts with the approval of the Board of Trustees.
- (vi) That Board of Trustees shall accept any donation, gifts contributions, grant or subscription in cash or in kind, from any person, body of persons or trust, with or without conditions.
- (vii) That the Board of Trustees shall represent the Trust in all legal matters and can sue and be sued for and on behalf of the Trust.
- (viii) That the Board of Trustees can apply the whole or any part of the income of the trust, or the trust fund or accumulations thereof for any one or more of the objects of the trust, as the Board of Trustees may decide from time to time.

OTHER POWERS OF THE BOARD OF TRUSTEES:

- (a) The Board of Trustees can convert and deal with the Trust property/and or any investments for the time being.
- (b) The Board of Trustees can invest the trust fund either in the purchase or mortgage of immovable property or in shares, stock or debentures or other securities and investments or in deposits, can advance loans to any company, bank, firm or any other persons and to alter, vary or transpose such investments from time to time at the discretion of the Board of Trustees.

- (c) The Board of Trustees can borrow or raise or secure payments of money and also lend money either with or without security.
- (d) The Board of Trustees can sell, dispose off, alienate or otherwise deal with any property comprising the trust fund and property.
- (e) The Board of Trustees can let out, demise any immovable property comprised in the Trust fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (f) Board of Trustees can adjust, settle, comprise, compound, refer to arbitration all actions, suits, claims, demands and proceedings regarding the Trust's funds and property.
- (g) The Board of Trustees can make vary, alter, or modify schemes, rules and regulations for carrying out the objects of the trust.
- (h) The Board of Trustees can start, abolish, discontinue and re-start any charity or charitable institutions for the benefits of general public and impose any conditions on any subscription or donation made by them.
- (i) The Board of Trustees can set apart and allocate the whole or a part of the income or the corpus of the trust fund or part thereof for any of the objects of Trust.
- (j) The Board of Trustees shall be empowered to :-
 - I. Settle all accounts and to compromise, compound, abandon or refer to arbitration any action or proceedings or disputes, claim(s), demand(s) or things as deemed proper for such purpose without being responsible for any loss occasioned there by.

- II. Borrow moneys either on the security of any property comprised in the trust fund or otherwise for all or any of the purposes of these presents and it shall be lawful for the Board of Trustees to make such borrowings on payment of such interest or otherwise on such terms and conditions as they may in their absolute discretion think fit.
- III. Takeover or merge with any other charitable Trust, society, association or institution with similar objects
- IV. Establish, promote, manage, organize or maintain or to assist in establishing promoting managing, organizing or maintaining any branch of the Trust or any other trust or its branch/branches with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other trust or trusts with this Trust.
- V. To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- VI. To purchase or otherwise acquire and undertake all or any part or the property, assets, liabilities and management of any or more of the Trustees, societies, institutions with which his Trust is authorized to amalgamate.
- VII. To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.



- (ix) The Board of Trustees will not be entitled to receive any salary but the Trustees may reimburse themselves of all expenses incurred by them in connection with the discharge of their duties relating Trust viz. T.A., D.A. and other allowances.
- (x) The Managing Trustee will, for the time being, be at liberty to appoint additional trustees within the number mentioned above for such period or on such terms as to retirement and reappointment as the Managing Trustee for the time being considers proper. A person shall cease to be a trustee either (i) if he without leave of absence does not attend three consecutive meetings of the Trust or for one calendar year, whichever is longer or (ii) if he is requested to resign by 3/4th or as near thereto as possible of the remaining trustees. (iii) the conditions (i) and (ii) above shall not be applicable for the Life Trustee.
- (xi) The trustee may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of any rule or regulations in this regard the following rules shall apply: -
- i) Three trustees, including the Life Trustee shall form a quorum for a meeting of the trustees.
 - ii) The decisions taken by the Board of Trustees, shall be subject to the written approval by the Managing Trustee/ Chairman of the Board. It is made clear that the Managing Trustee/Chairman shall not cast his vote wherever voting is required and the Managing Trustee will remain empowered to overrule or set aside any decision of the board of Trustees.
 - iii) Resolution passed without any meeting of the trustees but by circulation thereof and evidenced in writing under the hand of two thirds of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of trustees.

Further, in relation to the education institutions that shall be run under the aegis of the Trust, the following points shall be adhered to:-

- i) That the registration of the Trust shall be renewed at the prescribed time, if any.
- ii) That a nominee of the Director, Education shall be included in the Governing Body of the Trust.
- iii) That a reservation for a minimum ten percent of the total seats shall be affected for the meritorious students belonging to Scheduled Castes and Scheduled Tribes.
- iv) That after the affiliation with the Central Board of Secondary Education is obtained; the fees for the different classes shall not exceed the amount as prescribed by the Central Board of Secondary education.
- v) That no grant will be sought from the State Government, Uttar Pradesh for the educational institution in future.
- vi) That the salaries and allowances to the teaching and nonteaching staff shall not be lower than the salaries and allowances as prescribed by the Government.
- vii) That the terms of employment/service rules of all the staff of the educational institution shall be at par as prescribed for the staff in the institutions of the State Government as prescribed by the Central Board of Secondary Education, New Delhi.
- viii) That the order/guidelines as prescribed by the State Government, Uttar Pradesh from time to time in relation to the educational institutions, shall be followed.
- ix) That the records of the educational institution shall be maintained as prescribed by the State Government/Central Board of Secondary Education, New Delhi.
- x) That no change/addition/amendment shall be carried out in any of the above stated points without prior permission of the Government.

9. **BANK ACCOUNT:** The Managing Trustee shall along with one of the

Trustees open and operate all accounts in Bank and execute documents and represent the Trust. However the Managing Trustee, can, if he deems it necessary and expedient, to do so, empower any functionary, or functionaries of the organization/institution etc. working under the aegis of the Trust to open and operate the Bank accounts, execute documents' and represent the trust.

The word "he" has been used in the drafting of this deed to denote both the terms "he" as well as "she" and where required as such considering the gender of the person in the context.




